Amendment to Covenants, Restrictions, Easements, and
Community Association Applicable to The Retreat at Storm Branch

THIS AMENDMENT TO COVENANTS, RESTRICTIONS, EASEMENTS, AND
COMMUNITY ASSOCIATION is made and published as of this 28th day of June 2016, by

WITNESSETH;

WHEREAS, the Developer by Declaration of Covenants, Restrictions, Easements
Establishing and Providing for The Retreat at Strom Branch Community Association dated
March 27, 2009, recorded in the RMC Office of Aiken County, South Carolina in Deed Book
RB 4248, pages 1093-1112 did publish and declare certain Protective Covenants regarding The
Retreat at Storm Branch Subdivision; AND

WHEREAS, the Developer by Declaration of Rights, Restrictions, Affirmative
Obligations and Conditions Applicable to The Retreat at Storm Branch dated March 25, 2009,
recorded in the RMC Office of Aiken County, South Carolina in Deed Book RB 4248, pages
1113-1126 did publish and declare certain Protective Covenants regarding The Retreat as
Strom Branch Subdivision, Section One; and

WHEREAS, pursuant to the powers reserved by the Developer in Article VI of said
Covenants, Restrictions, Easements, and Community Association as amended, the Developer
desires to subject the property hereinafter known as The Retreat at Storm Branch, Section 3 to
said Covenants, Restrictions, Easements, and Community Association, as amended, said
property being described as follows:

All those lots or parcels of land, situate, lying and being in the State of South
Carolina, County of Aiken and being shown and designated as LOTS 40-59, inclusive
in Block E; LOTS 10-13, inclusive in Block F; of The Retreat at Storm Branch, Phase 3
and any Common Areas on a plat prepared by Southern Partners, Inc., dated May 9,
2016, and recorded in the RMC Office of Aiken County, South Carolina, in Plat Book
PL 59, Page 322; reference hereby being made to said plat for a more complete and
accurate description of the metes, bounds, and location of said property.

NOW, THEREFORE, the Developer does hereby subject the above-described property
to said Declaration of Covenants, Restrictions, Easements Establishing and Providing for The
Retreat at Storm Branch dated March 27, 2009, as subsequently amended; and

NOW, THEREFORE, the Developer does hereby subject the above-described property to said Declaration of Rights, Restrictions, Affirmative Obligations and Conditions Applicable to The Retreat at Strom Branch dated March 25, 2009, as subsequently amended.
